Tender Notice for Procurement and Installation of Tents and Mobile Toilets
Procurement Method: Local Open tender (LOP)

Date: 6 May 2025

1. Submission, Sealing and Marking of Bids

- 1.1 Bidders may submit their bids in hard copy.
 - a. For submissions in hard copy, the original and the copy of the bid (including alternative bids) must be enclosed in separate sealed envelopes, clearly marked as "ORIGINAL" and "COPY." These envelopes must then be placed together in a single outer envelope.

The envelopes containing the original and the copies shall be prepared as follows:

- The inner envelopes shall bear the name and address of the bidder.
- The outer envelopes must be anonymous and be addressed to AVEGA.
- The outer envelopes must be clearly marked with the specific identification of the bidding and a warning "Do not open before May 26, 2025, in accordance with the instructions.
- 1.2. If all envelopes are not sealed and marked as required, AVEGA will assume no responsibility for the misplacement or premature opening of the bid.

2. Deadline for Bids Submission

- 2.1 Bids must be received at the address specified in the Bid Data Sheet (BDS) no later than the date and time indicated.
- 2.2 AVEGA reserves the right to extend the deadline by issuing an amendment to the bidding documents.

3. Late Bids

Bids received **after the deadline** shall be considered late, rejected, and returned unopened to the Bidder.

4. Withdrawal, Substitution, and Modification of Bids

A bidder may withdraw, substitute, or modify its bid after it has been submitted by sending a **written notice**, duly signed by an authorized representative (along with a copy of the authorization, such as a power of attorney). The corresponding substitution or modification of the bid must accompany the respective written notice.

5. Bid Opening

- 5.1 AVEGA shall conduct the public bid opening at the address, date and time specified in the BDS.
- 5.2 Only envelopes that are opened and read out at the bid opening will be considered for evaluation.
- 5.3 All envelopes shall be opened one at a time, announcing:
 - The name of the bidder
 - Whether any modification or withdrawal notice was received
 - The bid price, including discounts and alternative (if any)
 - The presence or absence of required documents
 - Any other details as the AVEGA may consider appropriate

6. Responsiveness of Bids

- 6.1 AVEGA's determination of a bid's responsiveness is to be based on the **content of the bid** itself.
- 6.2 A substantially responsive bid is one that conforms to all the terms, conditions, and specifications of the bidding documents without material deviation, reservation, or omission.
- 6.3 A material deviation, reservation, or omission is one that:
 - Significantly affects the scope, quality, or performance of the Goods and Services
 - Limits in any substantial way, inconsistent with the bidding documents, the AVEGA's rights or the bidder's obligations
 - Would unfairly affect the competitive position of other bidders presenting substantially responsive bids.
- 6.4 Bids found **non-substantially responsive** shall be rejected and may not be corrected by the bidder after submission.

7. Non-Conformities, Errors, and Omissions

- 7.1 Provided that a bid is substantially responsive, AVEGA may waive minor nonconformities or omissions in the bid that do not constitute a material deviation.
- 7.2 Provided that a bid is substantially responsive, AVEGA may request bidders to submit missing information or documentation, within a reasonable period of time, provided such information is not related to the price of the bid. Failure of the bidder to comply with the request may result in the rejection.
- 7.3 Provided that the bid is substantially responsive, arithmetical errors shall be corrected as follows:
 - (a) if there is a discrepancy between the unit price and the line-item total that is obtained by multiplying the unit price by the quantity, the

unit price shall prevail and the line-item total shall be corrected, unless there is an clear decimal point error, in which case the line-item total as quoted shall govern and the unit price shall be corrected.

- (b) if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
- (c) if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.

If the lowest evaluated bidder does not accept the correction of errors, its bid shall be rejected.

8. Preliminary Examination of Bids

AVEGA shall examine the bids to confirm:

- Completeness of documents and technical documentation.
- Compliance with submission requirements.

9. Evaluation Criteria

Bids will be evaluated against the following criteria:

- Price/Cost Competitiveness
- Experience in Delivering Similar Products or Services
- Capacity to Deliver within the Allocated Timeframe.
